

Royal Air Forces Association Remembrance Garden: remembrance stone

At the cost of £500, a 400mm x 200mm remembrance stone, commemorating an individual, group or organisation can be laid alongside the pathway leading to the garden and around the central feature. The grey zephyr stone will feature an inscription set in stainless steel, headed with the RAF Association Wings emblem.

To ensure uniformity, the inscription for an individual will comprise the name of the person, rank, squadron or service number, where space allows. Recognised abbreviations of appropriate decorations, such as DFC, OBE etc. can be included after the name, space permitting.

The inscription for a RAF Association branch will comprise the branch number, followed by the branch name.



Orders for the stones will be made in batches of a minimum of ten. Once the order has been placed, it will take approximately 12 weeks for your stone to be inscribed and laid in the garden.
